Despite the insufficient resources the college strives to make the entire learning experience students centric by focusing on micro and macro level learning ideas for all the courses and make it a more interactive and participative experience. The classroom environment is made learner friendly. Various forums such as career counselling cell, placement cell, skill development cell and many others creative cells are working to enhance the skills of

the students. Emphasis is laid on proper academic preparation and syllabus completion. Separate lectures are organised for skill development. The initial few minutes of the lecture are devoted to the revision of the content cover in the previous lecture questions are asked to check the level of understanding of the students. The doubts of the students are cleared at regular periods. Faculty performance is closely monitored through student feedback and they are encourage to develop new experiments beyond syllabus. Guest lectures by eminent speakers are organised. The library is open for the students to engage in cells learning process.
